MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is an agreement for cooperation and collaboration in academic activities of Sri Manakula Vinayagar Engineering College - Pharmacy College, Madagadipet, Pondycherry-605107 (Hereinafter referred to as “SMVEC-Pharmacy College”)

and Goodman Pharmaceuticals , Thirubuvanai, Puducherry - 605107 (Hereinafter referred as "Goodman Pharmaceuticals "). The agreement shall be effective from the date of the signature, by the representatives of both the parties under the following terms and conditions:

This MOU details the modalities and general conditions regarding collaboration between SMVEC-Pharmacy College and Goodman Pharmaceuticals for enhancing research and institute-industry linkage collaboration in the areas of Pharma innovations between SMVEC-Pharmacy College and Goodman Pharmaceuticals. The areas of cooperation can be extended through mutuals consent.

NOW THIS MOU WITNESSETH AS FOLLOWS:

1. That the Parties on this day have executed this MOU with an intention to enhance the quality of the education for students and to train the faculty of the first party and also for the purpose of industry institute collaboration between the parties subject to the following terms and conditions:
 - a) Goodman Pharmaceuticals will provide the college with Training curriculum, connect with Goodman Pharmaceuticals training partners for learning contents, industry-Academia exposure and support events to uplift the capability of the students. The college shall use the materials and manage the efforts under the guidance of designated representative of Goodman Pharmaceuticals and exclusively for the purpose specified under this MOU.
 - b) The college shall nominate two or three faculty members for undergoing the Trainer Certification Program by Goodman Pharmaceuticals. The faculty, after completion of certification, will be allowed to train certain number of students as agreed upon by the parties in writing from time to time.
 - c) The partner shall establish a lab with the specified infrastructure requirements of Goodman Pharmaceuticals and shall use the lab for imparting the course /training. This lab shall be exclusive to the use of the purpose stated under this MOU and will not be used for running other courses of the Partner.
 - d) Goodman Pharmaceuticals would accommodate B.Pharm /D.Pharm students to undergo Internship/Inplant Training/Industrial visit/ Hands on Training in such a number that Goodman Pharmaceuticals deems convenient to it for the purpose.
 - e) Further, Goodman Pharmaceuticals may request to design and teach a course or courses which it deems fit to enhance quality and performance of its employees. Such courses may be run at any mutually convenient premises.
 - f) Goodman Pharmaceuticals may seek assistant/guidance of SMVEC-Pharmacy College faculty member/s and students in product/process modification, modernization, trouble shooting, etc.
2. The MOU shall be valid for five years from the date of execution and the parties shall be at fully liberty to terminate the MOU for convenience by issuing prior written notice of three months.
3. The parties shall take reasonable steps to ensure the successful performance of the obligations agreed including setting up of a joint Governing council consisting of the Dean and Head of Departments of the College and Subject matter experts and a Program Director from Goodman

Pharmaceuticals both to monitor/audit the program and cooperate with each other to duly perform the obligations agreed upon.

4. Any information and documentation received by the partner during the term of this MOU shall be deemed as 'Confidential Information' under this MOU. The confidential information includes, but it is not limited to, any information, course material, plans, discussions, strategies or any material provided by Goodman Pharmaceuticals to the partner and Goodman Pharmaceuticals technology including discoveries, inventions, research and development efforts, manufacturing processes and maintenance tools which may be disclosure by the Goodman Pharmaceuticals to the partner during the pendency of this MOU. Confidential Information shall also include any information marked "Confidential" or "Proprietary" but does not include any information already in the public domain or such information which was obtained from a third party. The partner shall not disclose, reproduce or use any confidential information for any purpose except solely in connection with the performance of this MOU. Upon expiration or termination of this MOU, Partner shall cease using all such confidential information and it shall either destroy or return all copies of such confidential information, in whatever form. The partner or any of its personnel/students/faculty shall not disclose the confidential information during the term of this MOU and for a period of 5 years after.
5. Except for collaboration related to full practice, the partner is not debarred from having collaborations with others.
6. Except as expressly started in this MOU, there shall be no obligation on any party to compensate the other in any manner or any claim. However, the terms and the conditions in this MOU shall be kept confidential.
7. The parties represents that they have the full power and authority to enter into this MOU in general and none of the objects stipulated herein are against public policy.

AMMENDMENTS

Any amendments and /or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendment or addenda.
